Further, the electricity tax on distribution, starting from 1 January, 2021 in tax class I = 2,253 cents/kWh + VAT 24 % (= 2,79372 cents/kWh) and in tax class II = 0,063 cents/kWh + VAT 24 % (= 0,07812 cents/kWh).

Tax category II for electricity tax is intended for data centers and business premises where industrial production or professional greenhouse growing is practised.

The electricity products above can also be chosen as a product of wind power, whereby all supplied electricity is free from carbon dioxide. This choice will add an amount of 0,25 cent/kWh (VAT 24) to the electricity supply charge.
